## **General Terms**

In order to obtain a license for use of space at **New England Model Train EXPO** (**NEMTE**), held at the Royal Plaza Trade Center (Exhibition Hall); 181 Boston Post Road West; Marlborough, Massachusetts 01752 sponsored by the HUB Division, Inc, the Organization agrees to the following terms and conditions and to any amendments, which may be issued subsequently.

- 1. The term "Organization" refers to Not-for Profit individuals, partnerships, associations and corporations.
- 2. The term "Dealer" refers to individuals, partnerships, associations, organizations and limited liability companies and corporations licensed to sell merchandise.
- 3. The term "HUB" refers to The HUB Division, Inc.

Organization releases HUB and its officers, directors, members, representatives and agents from all claims and demands arising from Organization's show occupancy, including but not limited to loss, theft, destruction or injury to Organization's business, merchandise or personal property. Organization releases HUB, its officers, directors, members, representatives and agents from all claims, loss, injury or demands arising out of HUB's failure to provide space, or failure to hold the show.

Organization understands HUB assumes no responsibility for any Organization merchandise or personal property or for the safety of the Organization at the show. Organization agrees to hold harmless HUB, its officers, directors, members, representatives and agents, the Exhibition Center, and Contractors from any and all claims, loss, injury or demands that arise from or in connection with the show. Organization agrees to indemnify HUB for any liability that may be caused by or related to their use of this license and presence at the show. This includes but is not limited to any liability caused by persons Organization provides "Dealer/Exhibitor" Badges for entrance into the show.

HUB does not allow Organizations to offer their assigned space to any other person or entity.

# Payment Terms

Organizations are provided floor space, as designated by the Show Manager, at the NEMTE <u>FREE</u> of charge as an attraction to benefit the NEMTE, the HUB, the NMRA and the railroad hobby. To obtain space, Organizations must complete and submit an Exhibitor • Module Group Application/Contract by <u>October 1</u>, <u>2024</u> and the Contract must be accepted by the HUB

## Sales by Organization

Organization agrees not to sell any articles or merchandise, including but not limited to Organization fundraising articles or materials, at the NEMTE as a restriction for receiving **NO CHARGE** space. Any Organization desiring to make sales at the NEMTE must also submit an Application/Dealer Contract in accordance with Dealer Terms and Conditions. Organization acknowledges that any abuse of this Contract Term will cause the Organization to be excluded from future NEMTE shows.

## **Sales of Organization Memberships**

Organization agrees that sales activity is limited **ONLY** to the sale of Organization memberships.

## Show Hours

The Show is open to the public from 10 A.M. to 4 P.M. on Saturday and 10 A.M. to 4 P.M. on Sunday. Set-up time is Friday from 2 P.M. to 9 P.M. and Saturday from 7 A.M. to 9:30 A.M. On Saturday the Exhibition Hall must be vacated by 4:15 P.M. or upon notification by the NEMTE Show Business Manager or NEMTE Show Director. In order to comply with security requirements, the Exhibition Hall will not be reopened to anyone except HUB Show staff until 9 A.M. on Sunday. The Exhibition Hall must be vacated by 7 P.M. on Sunday evening.

Organization agrees to keep its display/exhibit open to the public and not to remove any of its materials from the show area during show hours for the purpose of packing.

#### **Security**

The Exhibition Hall provides continuous security beginning Friday at set-up time through the time on Sunday that the Exhibition Hall must be vacated as stated the Show Hours section. The HUB assumes no responsibility for Organization loss. **NO ONE** will be admitted into the Exhibition Hall under any circumstances after the NEMTE Show Staff or HUB officials exit the hall.

#### Badges

"Dealer/Exhibitor" badges shall be issued by HUB to all Dealers and Exhibitors. Only Dealers and Exhibitors working the show shall be allowed to wear these badges.

#### "Dealer/Exhibitor" badges must be worn at all times.

Only personnel with authorized "Badges" will be permitted in the Exhibition Hall during times the event is not open to the public. Badges shall be issued by the NEMTE Show Staff upon arrival at the Exhibition Hall. Organization agrees that each of its members shall individually check-in and receive their badge. Organization agrees that any of its members working the NEMTE who are not Pre-Registered will be required to purchase a "Dealer/Exhibitor" badge at the current year adult admission price. **THERE WILL BE NO EXCEPTIONS**.

#### **Contracted Space**

This license limits an Organizations use of space to that which is approved in the Exhibitor • Module Group Application/Contract. Tables and chairs will be provided the Organization as stated in the Exhibitor • Module Group Application/Contract. If Available, additional tables or chairs may be provided to the Organization by the NEMTE Show Business Manager. Organization agrees not to add tables or chairs to their licensed space without the permission of the NEMTE Show Business Manager. Violations of this Term may cause a charge to be assessed the Organization and may cause the Organization to be excluded from future NEMTE shows.

#### Cancellation

Organizations may cancel their appearance at the NEMTE Show by providing written notice to the Show Director 90 days before the scheduled event. Failure to appear will cause the Organization to be excluded from future NEMTE shows.

HUB reserves the right to cancel the **New England Model Train EXPO** for weather related reasons, or for reasons beyond the HUB's control.

#### Accommodations

Hotel reservations are the responsibility of the Dealer. The **Best Western Royal Plaza Hotel** in Marlborough guarantees a special show discount rate of \$104.00 per night (single or double occupancy), \$114.00 per night (triple occupancy), \$124.00 per night (quad occupancy) for all reservations made by Friday, <u>November 6, 2024</u> After that date the special rate is on an "as available" basis at the discretion of the **Best Western Royal Plaza Hotel**.

When requesting the discounted rate, you must indicate that you are participating in the HUB Division New England Model Train EXPO show. Your room rate includes a Cold Continental Breakfast each day.
